CIRCULAR:-

A reference is invited to the Ordinance relating to the M.Sc. degree course, vide this office Circular No. UG/429 of 2009, dated 17th November, 2009 and the Directors/ Head of the recognized Institutions concerned and the Principal of the affiliated Colleges in Science are hereby informed that the recommendation made by the Faculty of Science at its meeting held on 14th November, 2014 has been accepted by the Academic Council at its meeting held on 26th February, 2015 vide item No. 4.75 and subsequently approved by the Management Council at its meeting held on 28th May, 2015 vide item No.16 and that in accordance therewith, in exercise of the powers conferred upon the Management Council under Section 54 (1) of the Maharashtra Universities Act, 1994 and the Ordinances 5883 relating to the eligibility criteria for Admission to the Five Year Integrated M.Sc. degree course in Bioanalytical Sciences is amended, which is available on the University's web site (www.mu.ac.in) and that the same has been brought into force with effect from the academic year 2015-16.

O.5883 be amended as follows:-

- i. A candidate for being eligible for admission to the 5 year Integrated M. Sc degree course in Bioanalytical Sciences must have passed Standard XII after 10 + 02 schooling (or equivalent) examination from any recognized board in India with minimum of 50% marks for student belonging to general category and 45 % marks for students belonging to Reserved Category in aggregate or equivalent grade with science, subjects Mathematics and Statistics, Biology and allied Sciences like Biotechnology etc) Chemistry and Physics.
- ii. Students who do not have Mathematics and Statistics be eligible for entry to the course subject to the successful completion of a 4 credit Bridge Course in Mathematics and statistics approved by Board of studies Maths & Stats before the end of semester I. The records of their lectures and their examination, results (with minimum 50% passing) should be submitted to the Controller of Examination before the end of semester I. The decision was accepted and it was resolved to put forth the same in Academic Council.
- iii. "The students who exit from the Five Year Integrated Course in bioanalytical Sciences with BSC degree may be allowed to join any other M. Sc course for which they become eligible depending on the credits in Biological Sciences, computational Sciences, Chemical Sciences they have earned in the first six semesters of the Five Year Integrated Course".
