Notice for Institutional Level Admissions: B.Ed. and M.Ed. for Principals of the Colleges and Candidates.

As per the provision in Maharashtra Act No. XXVIII of 2015 published in Government of Maharashtra Extra ordinary Gazette Part -8 Extraordinary No.94 Dated 17th August 2016 in Chapter II "REGULATIONS OF ADMISSIONS" 4. "Manner of Admission" (b) admissions to Private Professional Educational Institutions shall be carried out by the Competent Authority through Centralized Admission Process on the Basis of Common Entrance Test (CET) and Centralized Admission Process (CAP); and (c) the Competent Authority shall supervise and guide the Entire Centralized Admission Process in such manner as may specify with a view to ensuring that Process is fair, transparent, merit based and non-exploitative."

And

As per the provision in Government of Maharashtra Extra ordinary Gazette Part -4-B Extraordinary No.138 Dated 6th May 2016 in 13. Institutional Level Round.- "If the Seats remains vacant after all CAP Rounds, the seats shall be filled in by the institution through Institutional Level Round with the prior approval of the Competent Authority. The Principal of the Institution shall carry out the admissions to these seats in the following manner, -----

- (a) Admissions shall be made in a transparent manner and strictly as per the Inter-Se-Merit of the candidate who have applied to the Institution.
- (b) CET CELL will display the vacancies in the colleges of Education for B.Ed. and M.Ed. on line for Candidates to verify and apply.
- (c) Information Brochure published on the web site http://bed.mhpravesh.in and http://med.mhpravesh.in specifies the rules of admission will be applicable for admissions to Institutional Level Admissions.
- (d) Institutions will receive the applications from the candidates in the prescribed format uploaded by the State Common Entrance Test Cell on the web site http://bed.mhpravesh.in and http://med.mhpravesh.in as per the Time Table and Schedule of admission published on the web site.
- (e) The institution will give admission to the applicants on the basis of CET and Inter-se-Merit derived from Merit list declared by the Competent Authority for filling the vacant seats.
- (f) The institution shall prepare and display the Inter-Se- Merit list of the Candidates who have applied for Institutional Level Admissions for Seats after CAP round IV to be filled in at Institution level round on the College Admission Notice Board and shall publish the same on the web site of the Institution. The Institute will have

- to enclose the self -attested copy of the list to the Admission Regulatory Authority.
- (g) The colleges will give admissions by generating Provisional Admission Letter to the Eligible Candidates only through their log in and update admission status immediately through on line system. The colleges will be able to cancel the admissions through their log in only.
- (h) The CAP seats shall be filled by the Candidates from the same category for which it was earmarked during the CAP.
- (i) It is intimated to all Colleges and Candidates that there is no Institutional Quota available for B.Ed. and M.Ed. courses. All vacant seats will be filled in through Inter-Se-Merit in this round. The seats remain unfulfilled after this round will remain so.
- (j) Candidates who have not been allotted any seat in any of the previous rounds or those who have taken and cancelled their admission in the earlier rounds I,II,III and IV and final round are eligible to participate in this round. The candidates who have been already admitted will have to cancel his/ her admission from the earlier college on own risk then only their Admission Letter will be generated from the system.

Logic for Change of Category:

- **1. Group 1**: i) Scheduled Castes and Scheduled Castes converted to Buddhism (SC)
 - ii) Scheduled Tribes including those living outside the specified areas (ST)
 - **Group 2**: i) Vimukta Jati (VJ) / Denotified Tribes (DT) NT(A)
 - ii) Nomadic Tribes (NT-1) NT(B)
 - **Group 3**: i) Nomadic Tribes 2 (NT-2) NT(C)
 - ii) Nomadic Tribes 3 (NT-3) NT(D)
 - iii) Other Backward Class (OBC)
- 2. After following the stage IV(i) if some seats still remain vacant then those will be filled on the basis of a consolidated merit list of all remaining backward class candidates.
- 3.(a) After following the state Stage IV(ii) if some seats reserved for backward class remain vacant, they will be filled from the merit list of open category candidates.

Logic for Change of Subject/ Method.(Only for B.Ed.)

- 1. If the seats of particular subject remain vacant, those will be filled in by making changes as shown below by the Canalized Admission Committee. (Only for B.Ed.)
 - i. If seats remain vacant from the reservation of women in particular Subjects/Category then vacant seats will be merged in General Merit List of the same Category and Subject seats will be filled in.
 - ii. Interchange within Language Group.
 - iii. Interchange within Science and Agriculture/ Medical.
 - iv. Interchange between Information Technology, Engineering and Mathematics
 - v. Internal change between Science and Mathematics.
 - vi. If the seats remain vacant after executing above interchanges of **Languages**, **Science**, **Mathematics and Commerce**, then those seats will be distributed to **History Geography**, **Social Science** as per the quota allotted to these subjects in the Brochure.
 - vii. Inter changes between **History and Geography** after interchanging, if some Seats remain vacant, they will be allotted to **Social Science**
 - viii. If some seats still remain vacant, a consolidated merit list of all the subjects will be prepared and then seats will be filled on the basis of combined merit of all subjects.
- 2. If seats remain vacant any medium even after this admission will be given by changing the medium (as per the eligible medium given by the candidate)
