### **PROVISIONAL ADMISSION FOR LL.M. SECOND YEAR (THIRD AND FOURTH SEMESTER)**

**Students who have failed in more than two subjects in First & Second Semester are allowed to take Provisional Admission for LL.M., Third and Fourth Semester. (STUDENT MUST HAVE APPLIED FOR REVALUATION OF RSEMESTER – I OR SEMESTER – II EXAMINATION CONDUCTED IN MAY, 2019)** and subject to conditions mentioned in the Circular VCD No. Exam./ Photo & Rev./UNIV./VCD/4637 of 2010.

PROVISIONAL ADMISSION WILL BE CONFIRMED ONLY AFTER PRODUCING “ PASSED REVALUATION RESULTS” Students who have applied for Revaluation will be admitted provisionally for the above course. The forms for the same will be issued and collected by the office of the Department of Law. University of Mumbai, Fort Campus **from 2<sup>nd</sup> August, 2019 to 9<sup>th</sup> August, 2019** from 11.30 a.m. to 2.30 p.m. (1.00 p.m. to 1.30 p.m. Lunch Break).

**Following Self-attested documents are required to submit along with the Admission Form & Examination Form.**

- a. Two Sets of Sem. I & II attested marksheets for admission and examination forms respectively and to pay the examination fees for the third semester alongwith admission form.
- b. Candidate belonging to Reserved Category should submit copy of the Caste Certificate issued by Government of Maharashtra Only.
- c. Candidates belonging to OBC, SBC & VJ/DT/NT (A,B,C,D) must submit Non-Creamy Layer Certificate of current year 2018-19 along with the admission form.
- d. **At the time of Provisional Admission, students must submit Xerox Copy of Current 'REVALUATION RECEIPT' applied for the paper/s**
