## CIRCULAR

Sub:- Licensing of Units providing catering services in Colleges/ Universities and regulatory comliances by them-reg

The Principals/Directors of all affiliated/ recognised Colleges/Institutions and Head of the Departments/ Directors of University Departments/ Institutions are hereby informed that letter dated 29<sup>th</sup> December, 2017 received from the Food Safety & Standards Authority of India regarding the Hostel messes, canteens, cafeterias in your college premises whether run by your organisation or through other agencies are covered under the defination of Food Business Operatro (FBO), hence it is imperative for them to obtain a license and fulfill all the resonsibilities of an FBO as stipulated under section 23 of the Food Safety and Standards Act, 2006. As prescribed under Section 31(1) of FSS Act, 2006, no person shall commence or carry on any food business/ activity except under a license. Therefore, Food Business Operators (FBOs) engaged in Catering Units are under obligation under FSS Act, 2006 to not only obtain FSSAI license but also to follow the General Hygienic and Sanitary Practices (GHSP) as stipulated in Part V of Schedule 4 of FSS (Licensing and Registration of Food Business) Regulations, 2011.

It has come to notice that many such Catering Units are still operating without FSSAI license and very few actively follow GHSP in violation of the FSS Act, 2006 thereby attracting penal action which includes seizing of the premise, imposition of penalty and imprisonment.

Accordingly, all Catering Units whether in hostel's messes, cantenns and cafeterias in Colleges/Universities may be advised to take immediate action to apply for FSSAI License by 15.01.2018 without fail. The FBOs can apply for license online through FLRS portal i.e. <a href="https://foodlicensing.fssai.gov.in/index.aspx">https://foodlicensing.fssai.gov.in/index.aspx</a>. After the expiry of the above said timeline, the Commissioners of Food Safety of all States/ Uts will carry out surveys to indentify defaulting FBOs operating hostel's messes, canteens and cafererias in Colleges/Oniversities and take strict action under the FSS Act, 2006, Rules and Regulations made thereunder against the degaulters.
