Amendment in eligibility for S.Y.B.A. in German Studies from the academic year 2018- 19.

It was **resolved** that it be recommended to the **Academic Council** that the o.5610 relating eligibility Criteria for the Second Year of the B.A. in German Studies be amended to read as under and that same be brought into force with effect from 2018-2019:-

The existing 0.5610:

Eligibility Criteria for the Second Year of the B.A. in German Studies

F.Y.B.A. of the B.A. in German Studies offered by the University of Mumbai, or any other University, recognized by the University of Mumbai.

OR

First Year of the Bachelors' Programmes of the University of Mumbai in any discipline, or any other University, recognized by the University of Mumbai

+ Passed A2 level of the Goethe Institute/MMB or

Passed Diploma in German of the University of Mumbai, or any other University, recognized by the University of Mumbai or

having equivalent German language competence

+ Passed the written and oral Entrance Test of the Department of German, University of Mumbai

Calculation of credits: For candidates joining B.A. in German at the S.Y.B.A. level, 30 credits shall be assigned for the First Year and their First Year marks/Grades shall be calculated / converted into Grades (letter grade and grade point) according to the existing Marks-Grades conversion scale being followed by the University of Mumbai at the Department and be sent to the Exam House.

having equivalent German language competence

+ Passed the written and oral Entrance Test of the Department of German, University of Mumbai
