A. <u>Pay scales</u>: The pay scales are as prescribed by UGC/State Government. The present Pay scales of the post is as follows:

- **B.** Age: The Retirement Age for the above post is 60 years. However, minimum age shall not be less than 45 years.
- **C.** <u>Tenure</u>: The post is on Tenure basis for the period of <u>FIVE years</u>. The appointment made on this post is for the period of five years or the person attains 60 years, whichever is earlier.

D. The Minimum Qualifications & Experience for the post of Director - Alkesh Dinesh Modi Institute of Financial & Management Studies:

- An eminent scholar with Ph.D. qualification in the concerned / allied / relevant/applied discipline with evidence of published work and research guidance of high quality.
- ii. consistently good academic record with First Class (or an equivalent grade in a point scale wherever grading system is followed or 60%) in Master's Degree in Business Management/ Administration / in a relevant discipline or consistently good academic record with First Class (or an equivalent grade in a point scale wherever grading system is followed) in two-year fulltime PGDM declared equivalent by AIU / recognized by the AICTE / UGC;

First Class graduate and professionally qualified Chartered Accountant / Cost and works Accountant / Company Secretary of the concerned statutory body.

iii. Minimum of 15 years of approved experience in teaching and/or Research and/or Industrial Experience of which at least five years should be at the level of Associate Professor.

In case of research experience, good academic record and books/research paper Publications IPR/patents record shall be required as deemed fit by the expert members in Selection Committee. For Teaching and/or research experience, API as equivalent to that of Professor's post.

If the experience in industry is considered, the same shall be at managerial level equivalent to Professor with active participation record in devising/designing, developing, planning, executing, analyzing, quality control, innovating training, technical books/research paper publications / IPR / patents, etc. as deemed in Selection Committee.

Flair for Management and Leadership is essential. Post Ph.D. publications and guiding Ph.D. student is highly desirable

Relaxation in Qualification:

- i) The minimum requirement of First Class or 60% of marks at the Master's degree level is relaxable for the existing incumbents who are already in the University System.
- ii) A relaxation of 5% may be provided at the graduate and Masters level for the Scheduled Castes/Scheduled Tribes/Differently-abled (physically and visually differently-abled) /Other Backward Classes (OBC) (Non-creamy layer) categories for the purpose of eligibility and for assessing good academic records during direct recruitment to teaching positions. The eligibility marks of First class (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace mark procedures.

iii) A relaxation of 5% may be provided to the Ph.D. degree holders who have passed their Master's degree prior to 19th September, 1991.
