CIRCULAR: -

Ref: To conduct the Practical examinations in various subjects at T.Y.B.B.Sc. (Semester V) examinations to be held in the Second Half (Winter) of the year 2019.

The Principals of the affiliated Colleges in Arts, Science & Commerce, the Director, Institute of Science and the Directors of the Recognized Institutes are hereby informed that the Practical in various subjects at T. Y. B. Sc. (SEMESTER. V) examinations to be held in the SECOND HALF (WINTER) of the year, 2019 will be conducted before theory examinations.

To conduct of practical examination in Faculty of Science and Technology (Science group) various subjects for T. Y. B. Sc. Semester-V following may be directions be followed:

- 1. A committee of the Heads of departments of the given science subjects be constituted for each cluster to coordinate the conduct of these exams.
- 2. A designated member of the BoS (whether regular or Ad hoc Board) of the given subject shall be the chairman while the HoD of the lead College shall be the convenor of same. Where the lead College does not conduct a program in a given subject, the senior most Head of department from the constituent colleges in the cluster be nominated by the chairman as the convenor of the committee.
- 3. This committee shall prepare the schedule for practical examination for all colleges in the cluster.
- 4. The committee shall also prepare a list of examiners and make necessary appointments of external examiners for each college. In case of any difficulty regarding availability of the required number of examiners for a given subject the convenor in consultation with the chairman of the committee is authorised to appoint examiners from colleges not included in the cluster.
- 5. Half the number of required examiners shall be appointed as external examiners. Internal examiners shall be from the same college.
- Decision regarding setting of question papers for practical examination shall be taken by the committee of HoDs. The committee may appoint paper setters for the same.
- 7. Remuneration to the examiners including paper setting (where required), conduct of examination, TA/DA for the external examiners to be paid by the university and not by the lead College or the College conducting the exam. The bill forms for the same to be signed by the chairman/convenor of the committee and the principal of the college where the practical Exam is being conducted.
- 8. Mark lists to be prepared by the examiners and submitted to the lead College.

9. The cluster committee of HoDs shall take appropriate measures for preparation, collection and the submission of mark list to the university exam section.

If any teacher or non-teaching employee fails to comply with the order of the University or College or Institution, in this respect, it shall be treated as misconduct and the employee shall be liable for disciplinary action. In case of failure on the part of the teacher or non-teaching employee of any affiliated college, conducted college, community college or recognized institution, to comply with the order of the University in this respect, the Vice-Chancellor shall have power to take an appropriate action against them, which may include imposing penalties including suspension of approval to the appointment of a teacher as may be prescribed by the Statutes.
