I am to invite your attention to the Ordinances, Regulations and Syllabi relating to the Bachelor of Music Course **vide** this office Circular No.UG/253 of 2004, dated 16<sup>th</sup> June, 2004 and to inform you that the recommendation made by the Faculty of Fine Arts at its meeting held on 5<sup>th</sup> March,, 2015 has been accepted by the Academic Council at its meeting held on 29<sup>th</sup> May, 2015 **vide** item No.4.19 and subsequently approved by the Management Council at its meeting held on 26<sup>th</sup> June, 2015, **vide** item No. 05 and that in accordance therewith, in exercise of the powers conferred upon the Management Council under Section 54 (1) of the Maharashtra Universities Act, 1994 and the Ordinance 4006 relating to the eligibility criteria for admission to Bachelor of Music course is amended, which is available on the University's web site ([www.mu.ac.in](http://www.mu.ac.in)) and that the same has been brought into force with effect from the academic year 2015-16 and read as under:-

**O. 4006 :-** Eligibility :- A candidate for being eligible for admission to the Degree of Bachelor of Music must have passed

(a) HSC (Std.XII) examination conducted by the Maharashtra State Board of Higher Secondary Education or an Examination of another body recognized as equivalent thereto and passed the Diploma in Music of this University or Sangeet Madhyama Purna from the Akhil Bharatiya Gandharva Mahavidyalaya Mandal, Mumbai.

**OR**

(b) HSC (Std.XII) examination conducted by the Maharashtra State Board of Higher Secondary Education or an Examination of another body recognized as equivalent thereto with Music as one of the subjects.

The candidate's admission to the course will be subject to his/her passing an audition test conducted by the Head of the Institution where the candidate seeks admission. The candidates who have passed the Diploma in Music Examination of University of Mumbai in "A" Grade or above are exempted from the Audition Test.
