I am to invite your attention to the Ordinances, Regulations and Syllabi relating to the Master of Music Course <a href="vide">vide</a> this office Circular No.UG/254 of 2004, dated 16<sup>th</sup> June, 2004 and to inform you that the recommendation made by the Faculty of Fine Arts at its meeting held on 5<sup>th</sup> March,, 2015 has been accepted by the Academic Council at its meeting held on 29<sup>th</sup> May, 2015 <a href="vide">vide</a> item No.4.19 and subsequently approved by the Management Council at its meeting held on 26<sup>th</sup> June, 2015, <a href="vide">vide</a> item No. 05 and that in accordance therewith, in exercise of the powers conferred upon the Management Council under Section 54 (1) of the Maharashtra Universities Act, 1994 and the Ordinance 4011 relating to the eligibility criteria for admission to Master of Music course is amended, which is available on the University's web site (<a href="www.mu.ac.in">www.mu.ac.in</a>) and that the same has been brought into force with effect from the academic year 2015-16 and read as under:-

## O. 4011 :- Eligibility:-

A candidate for being eligible for admission to the course for the Degree of Master of Music (Vocal) M.Mus. (Music Vocal) must have passed

a) Bachelor of Music (Hindustani Classical Vocal) of this University or a Degree of any other University or body recognized as equivalent thereto.

## OR

b) Bachelor of Arts of any other University or Body recognized by this University with specialization in the subject of Music.

## OR

 a) Passing of any other Music Examination recognized by this University provided the candidate is Bachelor's Degree holder of any other recognized University.

- b) Passing of any of the following examinations
- 1) Sangeet Visharad examination from Akhil Bharatiya Gandharva Mahavidyalaya Mandal, Mumbai.
- 2) Sangeet Prabhakar from Prayag Sangeet Samiti.
- 3) Sangeet Prabuddha from Bhatkhande Sangeet Sansthan, (Lucknow).

Provided the candidate is a Bachelor's Degree holder of any recognized University.

with outstanding Provided, however, persons performing abilities and sufficient theoretical knowledge in the field of Music who are graduates in any faculty of this University or of any recognized University may be admitted to this Post Course on the recommendation Degree Graduate of the Head of the Institution in which they seek admission. The candidate's admission to the course will be subject to his/her passing an audition test. All the candidates seeking admission except those holding (Hindustani Classical Vocal) Degree Bachelor of Music of this University securing 'A' And above grades appear for audition test to be have to Head of the Institution where the conducted by the admission is sought.
