Madam,

I am to invited your attention to Ordinances, Regulations and Syllabi relating to the Master of Science (M.Sc.) (Home Science) degree program vide this office Circular No. UG/292 of 2011, dated 16th September, 2011 and to inform you that the recommendation made by the Faculty of Science at its meeting held on 22nd June, 2015 has been accepted by the Academic Council at its meeting held on 26th June, 2015 vide item No.4.2 and subsequently approved by the Management Council at its meeting held on 27th June 2015 vide item No.18 and that in accordance therewith, in exercise of the powers conferred upon the Management Council under Section 54 (1) of the Maharashtra Universities Act, 1994 and the Ordinance 5088 relating to the eligibility criteria for Master of Science (M.Sc.) (Home Science) degree program is amended with addition of new branches No.V & VI, which is available on the University's web site (www.mu.ac.in) and that the same has been brought into force with effect from the academic year 2015-16 and read as under:-

O.5088 :- A candidate for being eligible for admission to the Master of Science (Home Science) course must have passed the Bachelor of Science (Home Science) Degree examination of this University or an examination of any other University recognized as equivalent thereto.

BRANCH I : HUMAN DEVELOPMENT

For being eligible for admission to the Master of Science (Home Science) degree course by papers in the branch of Human Development, a learner must have passed either -

- Bachelor of Home Science with specialization in Human Development/Child Development or any sub specialization such as Early Childhood Education and Developmental Counselling.
- Bachelor of Science with Human Development/Child Development.
- Bachelor of Home Science with any branch (Foods, Nutrition and Dietetics, Textile and Fashion Technology, Community Resource Management, Extension Education).

- Bachelor of Arts : Psychology/Sociology as a major/ part fulfillment.
- Bachelor of Arts with Education as a major.
- Bachelor of Social Work.
- Bachelor of Science/Arts (B.Sc./B.A.) Human Science.

BRANCH II : FOOD, NUTRITION & DIETETICS

For being eligible for admission to the Master of Science (Home Science) degree course by papers in the branch of Foods, Nutrition & Dietetics, a learner must have passed either :

- Bachelor of Home Science with specialization in Foods, Nutrition & Dietetics.
- B.Sc. with Home Science (any branch).
- Bachelor of Science with Biological Sciences.
- Bachelor of Science Chemistry.
- Bachelor of Science/Arts Human Science.
- Bachelor of Science Interdisciplinary Science with Biological Sciences and Chemistry at third year.
- Learners of any gender are eligible to apply for admission to the course.

BRANCH III : TEXTILE AND FASHION TECHNOLOGY

For being eligible for admission to the Master of Science (Home Science) degree course by papers in the branch Textile and Fashion Technology, a learner must have passed either –

- Bachelor of Science with Textile & Clothing.
- Bachelor of Home Science with specialization in Textile & Clothing/Clothing & Textile.
- Bachelor of Home Science with specialization in Textile & Fashion Technology.

- Bachelor of Home Science with specialization in any branch of Home Science of the University of Mumbai.
- Bachelor of Home Science (General).
- Bachelor of Science in any specialization.
- Bachelor of Fashion Design or Bachelor from any Design Stream.
- Bachelors degree in any stream of education such as BA, BCOM,BBA, BCA, BMS, BMM, B.Pharm., B.Tech., B.Arch., etc.

Bridge Course/Tutorials for Bachelors students from non Textile,Clothing & Fashion Background.

- PG Diploma in Interior Decoration/Interior Design

BRANCH V : FOOD PROCESSING & PRESERVATION

For being eligible for admission to the Master of Science (Home Science) degree course by papers in the branch Food Processing and Preservation, a learner must have passed either –

- B.Sc. with Home Science. (any branch).
- B.Sc. with Microbiology/Biochemistry/Life Sciences/Chemistry/Biotechnology/Combinations.
- B.Sc. with Agriculture.
- Bachelor of Science (B.Sc.) – Biological Sciences.
- Bachelor of Science/Arts (B.Sc./B.A.) – Human Science.
- Bachelor of Science (B.Sc) – Interdisciplinary Science with Biological Sciences at third year.
- Learners of any gender are eligible to apply for admission to the

BRANCH VI : SPORTS NUTRITION

For being eligible for admission to the Master of Science (Home Science) degree course by papers in the branch Food Processing and Preservation, a learner must have passed either –

- B.Sc. with Home Science (any branch).
- B.Sc. with Biochemistry, Life Sciences, Chemistry.
- B.Sc. with Nursing/Physiotherapy/Bachelor of Physical Education.
- Medical graduates any discipline (MBBS, BAMS, BHMS, BDS).
- Bachelor of Science (Biological Sciences).
- Bachelor of Science/Arts (B.Sc./B.A.) – Human Science.
