All the Principals/Directors of affiliated colleges, Director/Co-ordinator of University Thane Sub-Centre and I/c Director, University of Mumbai Law Academy conducting LL.B. (3 years) (Sem.I) examinations are hereby informed that the Hon'ble High Court, Mumbai in following Public Interest Litigation praying for the postponement of LL.B. examination has passed the following order on 24th January, 2018:

“6.(i) Such of the students who do not appear in the examination which is scheduled to commence from 29th January, 2018, such non appearance should not be considered as a failure to appear in the first semester examination;

(ii) Such students who opt not to appear in the examination commencing from 29th January, 2018, would be permitted to appear for the examination of the papers of the first semester along with the papers for second semester simultaneously and the said appearance would be treated as first appearance.”

The Hon'ble Court also clarified that the students who do not desire to offer themselves for the examination commencing from 29th January, 2018, such students shall communicate to the colleges concerned that they will not be offering themselves for the examinations commencing from 29th January, 2018 and that they would appear for the first semester alongwith the papers for second semester simultaneously. The said intimation be given to the colleges by 29th January, 2018 and the colleges concerned shall forward the said intimation to the respondent – University so that the University can well in advance prepare itself for the number of students who will be appearing simultaneously for the first and second semesters.

They are, therefore informed to forward the list of students of their college who do not desire to offer themselves for the LL.B. (3 Years) (Sem. I) examination commenced from 29th January, 2018 and that the students will appear for the first semester along with the papers for second semester simultaneously and the same be submitted latest before 5th February, 2018 to the Assistant Registrar, Result Unit (Law), First Floor, Examinations Section, M.J. Phule Bhavan, Vidyanagari, Santacruz (East), Mumbai -98 by hand delivery, accordingly.
