Rules and Regulations of the International Students House, University of Mumbai

ELIGIBILITY FOR HOSTEL ADMISSION

- 1. Only Foreign National students admitted to a full-time programme of study are eligible to apply for hostel accommodation.
- 2. Students who accept employment will lose their entitlement to hostel accommodation.
- 3. Students residing in Mumbai and suburbs upto Virar, Kalyan and Panvel shall not be considered for hostel admission. Age limit of the students should not be more than 30 years for P.G. and 35 years for Ph.D.
- 4. If a student seeking admission to a higher course of the same level for which he was enrolled earlier (like graduation to graduation; masters to masters etc.) by changing subject/faculty shall not be considered for hostel admission.
- 5. Submission of an undertaking that he is not resident of Mumbai and suburbs up to Virar, Kalyan and Panvel do not have his or family accommodation/quarters in areas mentioned as above and falling to give correct, information as above shall be liable for termination of hostel admission and also an undertaking that he abide by all rules and regulation of the hostel

DISCIPLINARY RULES

- 1. All the residents of the hostel should see that there is no waste of water, electricity and other facilities or common utilities provided to them. They shall be always economical in their use.
- 2. Students will not disturb their neighbors or others by playing loud music or by creating noise.
- 3. Fans and lights should be put-off before leaving the room. Failures will be fined As. 50/- per day.
- 4. The use of electrical heating appliances and cooling in the rooms is strictly prohibited due to safety requirements of the hostel.
- 5. The cost of damage, (if any) caused due to the electrical installations, furniture etc. in the room or to any of the parts of the hostel premises will be recovered from the student concerned.
- 6. Storage and consumption of alcoholic drinks/drugs/narcotics in the hostel premises is strictly prohibited. Anyone found indulging in these will be expelled instantly from the hostel and could be handed over to police.
- 7. Drinks/Drugs/Smoking inside the hostel premises is strictly prohibited. If found doing so, disciplinary action will be taken.
- 8. No student can remain absent from the hostel between 11.00 p.m. to 6.00 a.m. without prior permission/intimation to the Warden. Time limit for the late pass for the hostelites is 11.30 p.m. The hostel gate will be closed at 12.00 mid night every day.
- 9. Maximum two late passes will be allowed and every student should take prior permission of the Warden for remain absent from the hostel and should inform the proper address and telephone no of the place where he wants to stay night out prior to permission.
- 10. Students who are expected to remain absent from the hostel for 3 days or more should fill in the gate pass and ensure that, it is signed by the concerned authority before their departure.
- 11. If the student loses the duplicate key of the room, then he has to replace the room lock.
- 12. If any student found to be misbehaving in the hostel the same shall be communicated to the Head of the Department/Institute by the Hostel Regulatory Disciplinary Committee (HRDC).
- 13. No student can speak directly to the media or neither police nor they shall allow them media or police or outside persons to visit the premises of the hostel.
- 14. No student can take any complaint to the VC/PVC/Registrar and Police Department directly. The same must be submitted through the Warden..
- 15. There shall be Five-member body of students nominated by HRDC, for liaison between students and administration.
- 16. Every student, staying in a University Hostel must bring a certificate of satisfactory attendance and a recommendation for continuation from Head/Director of the department/Principal of Institution where he is enrolled, at the beginning of each term. If a student fails to bring such a certificate and recommendation within the stipulated time period, his admission to the hostel would be cancelled immediately without giving any notice.
- 17. The maximum period of stay allowed in the hostel is as follows:

Ph.D.	3 academic years	1 + 1 year with recommendation of guide and HOD/Director/Principal

- 18. The student shall be responsible for the safety of his articles belongings cash etc. in his room.
- 19. In case the student is getting UGC/CSIR/Govt. fellowship he shall pay the HRA to the University.

PENALTIES

- 1. For entertaining unauthorized guest Rs. 250/- per day.
- 2. Remaining away from the hostel for more than 3 days without prior permission-Rs. 100/
- 3. Using electrical gadget for cooking and other purpose in the room- As. 250/- week.
- 4. Handling over the key to unauthorized persons-Rs. 250/
- 5. Consumption of alcoholic drinks/drugs in the hostel premises Rs. 500/- and/or immediate expulsions.
- 6. Nonpayment of hostel fees in due time Rs. 50 per day till next 10 days or before due date, Admission liable to cancel 10 days after due date.
- 7. Damage to property, furniture-cost recovery.

VISITORS/GUESTS

1. Visitors are allowed between 9.00 a.m. to 9.00 p.m. (all days) with proper entry in the Visitor's Register.

2. No female guests are allowed to enter in the hostel.

3. It is the responsibility of the student to see that the guest leaves the hostel before 9.00 p.m. The visitors found between 9.00 p.m. to 9.00 a.m. will be considered as an illegal occupant and concerned hostellite will be penalized as per the norm.

4. If the student found allowing guests three times illegally in the year then he loses hostel admission.

- 5. The guests can be accommodated in the guest room only after the prior permission of the Warden and after filling the Guest Form. Guest needs to deposit the room charges in advance.
- 6. A student of the hostel may be allowed to accommodate a guest for not more than two consecutive nights (only on payment of Rs.500/- per day as guest charges.)

7. The student may accommodate not more than one guest for overnight stay on payment of guest charges.

8. The guest charges are Rs. 500/- per head per day payable on the same day of the arrival of the guest.

9. Only parents /guardians of the medically ill students may visit the hostel and stay for one night free of charge. Thereafter if they have to stay on doctor's recommendation shall be allowed to stay for three days more at 50%charges.

FEES (Enternational Student's Hostel)

- 1. The students need to pay the fees on prescribed due dates every year at the time of taking admission only. Defaulters need to pay Rs.50/- per day late fee for next fifteen days. Thereafter the hostel admission will be cancelled.

3. Summer vacation charges;

The period between completion of examination and the date of commencement of new academic term is to be deemed as summer vacation. M.Phil./Ph.D students, who are required to stay during vacation for appearing NET/SET or any competitive examination should submit an application to the effect duly endorsed through the Principal/Director of their respective College/Institute and pay vacation charges as admissible. Rs. 400/- per day on daily basis for Single Bed and Rs.200/- per day for Triple Bed.

4. Students studying UG/P.G. degree needs to vacate the room within five days from the last date of their Examination. Students who desire to stay to write statutory examinations shall apply for stay in vacation till last date of

examination and shall obtain prior permission and shall pay as per rule No. 3 above.

5. No vacation charges are applicable to M.Phil. and Ph.D. students provided the research guide certifies that he is required to stay during vacation to complete his research assignments.

6. The Master's Degree part-II and final year degree student's needs to vacate the hostel within five days from the last date of their examination. They will be charged guest charges (i.e. Rs. 500/- per day in advance) after the ten days completed till a maximum period of fifteen days.

7. Those who do not appear for examination for whatever reasons will have to vacate room on last day of term.

8. Students who need to use computer and such electronic equipments need to take prior permission and need to pay Rs. 500/- (Rupees Five hundred only), per term against electricity charges.

MISCELLANEOUS

1. Students are requested not to bring too many personal belongings, expensive gadgets, large sums of money. Money kept in the room for current use should be locked and the key should be kept with the student himself. University does not hold the responsibility for the loss of anything from the student's room, but any loss is to be reported immediately to the Warden.

While vacating the room it is the responsibility of the student to get the clearance of dues and hand over the key to the office with due signature of the Warden on the counterfoil of the gate pass for no objection as far as breakage of

hostel property. (i.e. furniture, electrical connections, damage in the room etc.)

3. Student should submit the gate pass and the deposit refund application (if applicable) at least eight working days in advance before vacating/leaving the hostel premises.

4. The News Paper, Magazines or any reading materials should be used in the reading room. No one should take these materials outside.

Student should use dustbins only for disposal of the waste and no one should throw papers or waste materials out of the window and in the corridors of the Hostel.

6. If you are not well immediately see a doctor. As far as possible University appointed doctor should be consulted. Do not wait till the illness becomes serious.

7. No students will be allowed to use the shower and must use the bucket and mug.

8. Hot water will be available between 6-30 a.m. to 8.30 a.m. only

 Any deviation in observing these rules will be observed as serious offence and the offender will be fined or suitable disciplinary action will be initiated against him.
