- 3. <u>In case of OBC/SBC/NT/DT candidates, a non-creamy layer certificate for the current financial year (2018-19) should be submitted in original.</u>
- 4. <u>If the candidate fails to produce the required certificates in original at the time of admission, he/she will forfeit the claim for admission.</u>
- 5. The candidate will be issued <u>four</u> copies of the challan for payment of the prescribed fees (<u>Rs.59,145/-</u>) in Allahabad Bank, Kalina Branch, Wadia High School compound, Ground Floor, Opposite Vidyanagari Campus. <u>The candidate should pay the prescribed fees in the bank on the same or following day.
