 - a. Mark Sheets or Gazette (attested by respective college Principal) of LL.B. (First Semester to Final Semester)
 - b. Candidate belonging to Reserved Category should submit copy of the Caste Certificate only from Government of Maharashtra.
 - c. Candidates belonging to **OBC, SBC & VJNT / DT / NT (A, B, C, D), EWS, SEBC (Maratha)** must submit **Non-Creamy Layer Certificate** along with the application form. (Receipt of application for Non-Creamy Layer Certificate to the appropriate authority will be accepted. Student must produce original Non-Creamy Layer Certificate of current year 2019-20 at the time of Admission.)
 - d. Candidates applying for Other Quotas (Divyang, Freedom Fighter, Sports etc.) the necessary documents should be submitted.
 - e. Orphan Student - Valid documentations
 - f. **SEBC (Maratha)** – Valid Caste Certificate issued by Government of Maharashtra, Receipt of application for Caste Certificate, School Leaving Certificate.
