## **ELIGIBILITY**

The Department of Law, University of Mumbai is conducting All India LL.M. Entrance Examination for admission into LL.M. (Two Years) Degree Course for the academic year 2017-2018.

**Eligibility** : Candidates who have <u>passed LL.B. Degree Course</u> or those who are in the <u>Final Semester of 3 or 5 years LL.B. Degree Course</u> from the University of Mumbai or Other Universities are eligible to apply for LL.M. Entrance Examination.

An application for LL.M. Entrance Examination for admission to the LL.M Degree Course must be made in the prescribed form to be downloaded from the University Website <u>http://mu.ac.in/portal/department-of-law/</u> and duly filled in form be submitted to the Department of Law within the prescribed time and venue mentioned below.

ADMISSION OF THE STUDENTS SHALL BE MADE STRICTLY IN ACCORDANCE WITH THE MERIT IN THE LL.M. ENTRANCE EXAMINATION SUBJECT TO RESERVATION POLICY OF THE GOVERNMENT AND RULES PRESCRIBED BY THE UNIVERSITY.

Candidates are required to secure Minimum Qualifying Marks in the LL.M. Entrance Examination as under:

40% – General Category 30% – Reserved Category

<u>The LL.M. Entrance Examination Test paper will consist of 50 Objective type questions</u> with multiple choice for total 100 marks. There shall be no negative marking for wrong answers.
