

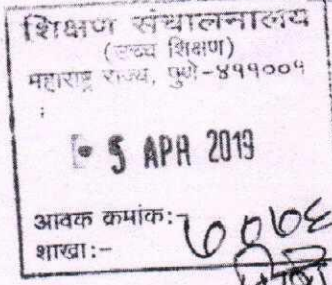

I am directed to say that the Election Commission of India has declared the General Elections to the Lok Sabha, 2019 and has also imposed Model Code of Conduct (MCC) w.e.f. 10.03.2019.

2. The Election Commission of India, vide their letter No.437/6/CG/ECI/LET/FUNCT/MCC/2019 dated 20th March, 2019 (copy enclosed), in response to this Department's letter No.14-4/2014-NLM-III dated 15th March, 2019 (copy enclosed), has conveyed their No Objection from MCC angle to the release of grants-in-aid "subject to the following conditions:-

- (i) There shall be no publicity in this regard in electronic, print, radio, internet or any other media, in any form whatsoever.
- (ii) No political functionary shall make any reference in this regard during any public speech or communication to the press or public.



Subject: Request for clearance from ECI for releasing grants under Saakshar Bharat programme to States/UTs during 2018-19 - regarding.

Saakshar Bharat, a Centrally Sponsored Scheme of Adult Education & Skill Development was launched on 8th September, 2009 to impart functional literacy to adults in the age group of 15 years and beyond with prime focus on women besides SCs STs, Minorities & other disadvantaged groups in rural areas of the districts that had adult female literacy rate of 50% or below, as per 2001 census and Left Wing Extremism affected districts, irrespective of their literacy rate.

2. The Scheme was extended for 12 months beyond XII Five Year Plan i.e., from 1st April, 2017 to 31st March, 2018 without changing the scope, nature, coverage and norms of the existing Scheme. Subsequently, the D/o Expenditure vide their O.M. dated 27.07.2018 conveyed that approval of Hon'ble Finance Minister for continuation of the Scheme till the committed liability are paid off of 31.12.2018. Thereafter, the D/o Expenditure vide their O.M. dated 21.12.2018 has conveyed their approval for extension of the Saakshar Bharat Scheme till 31st March, 2019.

3. In this context, it is to mention that BE 2018-19 for Saakshar Bharat Scheme is Rs.320 crore and RE is Rs.52.95 crore. Out of this RE, the balance amount is Rs.19.28 crore. The D/o School Education & Literacy is processing for release of grants-in-aid to the eligible States/autonomous bodies.

4. In the meantime, the Election Commission of India (ECI) has declared the General Elections to the 17th Lok Sabha and as such Model Code of Conduct (MCC) is in force now.

5. Therefore, the ECI is requested to kindly convey their approval to the release of the balance amount subject to eligibility of the States/autonomous bodies during the financial year 2018-19, in view of the Code of Conduct in force due to the declaration of General Election to the 17th Lok Sabha, 2019 & State Assemblies Election.
