They are hereby informed that the recommendations made by the Board of Studies in Latin Greek and Modern European Languages at its meeting held on 30<sup>th</sup> March, 2019 have been accepted by the Academic Council at its meeting held on 15<sup>th</sup> April, 2019 (**vide** item No. 4.9) and subsequently approved by the Management Council at its meeting held on 26<sup>th</sup> April, 2019 (**vide** item No. 19) and that in accordance therewith, in exercise of the powers conferred upon the Management Council under Section 74 (4) of the Maharashtra Public Universities Act, 2016 (Mah. Act No. VI of 2017) the amendment of O.6032 relating to the eligibility criteria, duration and intake capacity of Certificate Course in French (Intensive), has been brought into force with effect from the academic year 2019-20, accordingly.
