A reference is invited to the Syllabi relating to the Master of Commerce (M.Com.) degree programme vide this office Circular No. UG/110 of 2016-17 dated 25th October, 2016 and all the Directors / Heads of the University Departments, Principals of affiliated Colleges, Heads of the Recognized institutions & Chairpersons of the Board of Studies & all other concerned are hereby informed that the proposal passed by the Board of Examinations and Evaluation at its meeting held on Sunday, 2nd July,2017 vide item no. 01, regarding M.Com Semester I to IV New ATKT Rules from the academic year 2017-2018 has been accepted by the Hon'ble Vice Chancellor as per the power confirmed upon him under Section 12 (7) of the Maharashtra Public Universities Act, 2016

M.Com Semester III & IV Existing Rule

1) A learner shall be allowed to keep term for semester –II irrespective of number of courses of failure in the Semester- I

2) A learner shall be allowed to keep term for semester -III if he/she passes each of the Semester-I & Semester-II, or a learner fails in not more than two courses of Semester-I and not more than two courses of Semester-II.

New ATKT Rule from $\ \, \text{academic year 2017-2018 For M.Com}: Semester- II, III & IV$

A) Semester- II

A learner shall be allowed to keep term for semester -II,

- i) Notwithstanding, that he/she may not have appeared for Semester- I
- ii) OR, irrespective of number of courses of failure in the Semester- I
- b) Semester- III

A learner shall be allowed to keep term for semester -III,

- i) Notwithstanding, that the learner may not have appeared for the Examinations of Semester-I & or Semester-II, OR,
- ii) Irrespective of number of courses of failure in the Semester-I and/ or semester-II,
- c) Semester -IV

A learner shall be allowed to keep term for semester -IV,

- i) irrespective of number of courses of failure in the Semester-I and/OR Semester-II, and/OR Semester-III,
- ii) A learner is allowed to appear for semester –IV Examination' but the result of semester –IV shall be **kept in abeyance** until the learner passes all courses of Semester I, II, & III.
