It is observed that a large number of colleges affiliated to the Universities under your jurisdiction have not settled the accounts of grants received from UGC under various schemes during IX, X and XI Plans. Non-settlement of previous Plans accounts has been viewed very seriously by the UGC and the Ministry of Human Resource Development, Government of India. Therefore, it has been decided to take up the issue of settlement of previous Plans accounts on top priority and in a time bound manner.

Kindly convey to the Colleges that "no further grants would be released to the colleges under various schemes till the accounts of previous plans are settled."
