
**Sub. : - The President of India, Dr. Shanker Dayal Sharma

Attention of the Directors/Heads of the University Departments, Principals/Deans of the affiliated Colleges and Heads of the recognized Institutions conducting Post-graduate courses is invited to the criteria for the award of **"The President of India, Dr. Shanker Dayal Sharma Gold Medal"** (copy enclosed) and each of them is requested to recommend one name of the student to the Dean of concerned Faculty on or before **30<sup>th</sup> September, 2015**, for the award of the medal for the year **2015**.

As per the criteria the Directors/Heads of the University Departments, Principals/Deans of the affiliated colleges and Heads of the recognized Institutions have to recommend the names of their students for the award of the Medal to the respective Deans of the Faculties of University (copy enclosed) and each of the Deans will then forward, **a single nomination** from amongst those received by them for the award of the Medal for consideration on or before **16<sup>th</sup> October, 2015**.

### Criteria for the award of **"THE PRESIDENT OF INDIA, DR. SHANKER DAYAL SHARMA GOLD MEDAL"**.

1. A Silver Medal plated with gold, struck by using a small plain die, (as is usually done in a case of many other medals at the examination) shall be awarded every year to a \* Post-graduate student of the University, who in opinion of the Selection Committee, deserves it.
2. The Selection Committee shall consist of the following members:-
  1. The Vice-Chancellor (Chairman)
  2. One Dean of any Faculty nominated by the Vice-Chancellor
  3. One member nominated by the Management Council
  4. One eminent citizen of Mumbai nominated by the Vice-Chancellor (such a person could be, e.g. chairman, Atomic Energy Commission/Director, B.A.R.C./I.I.T. Mumbai/One of the Dean of I.I.T./Retired Judge/Leading Literary person etc.)
3. The Selection Committee shall consider a list of students consisting of **ONE** nominee of each Faculty. This single nomination per Faculty shall be made by the Deans of that Faculty. In case for any reason any faculty does not have a Dean in position, the Vice-Chancellor shall ask the immediate previous Dean of the Faculty to make the nomination. The Deans shall evolve a suitable procedure to prepare a Faculty list of students consisting of one student each recommended by Head/Director/Principal of each Department of the University/Institute /College, respectively where Post-graduate courses in his faculty are conducted: the Dean shall then make his single nomination form this Faculty list.
4. For the purpose of preparing the Faculty list of students and also for nomination of the Faculty student to the Selection Committee the broad criteria to be considered shall include (a) Academic Achievements, (b) Extra-Curricular activities, (c) Sporting activities, (d) Leadership and (e) Personality.

Information of each nominated student shall be prepared giving details related to the criteria mentioned above and the Head of the Department/Director of the Institute/Principal of the College shall make specific recommendations and send the same to the Dean.
5. The Selection Committee shall interview students nominated by the Deans of the Faculty and base their evaluation on the Criteria mentioned in 4 above and the performance in the interview also. Recommendation of the Selection Committee for award of the **"The President of India, Dr. Shanker Dayal Sharma Gold Medal"** shall be made by October/November.

6. In case of any ambiguity in the recommendation, the Management Council shall take a final decision in the matter.
7. The presentation of the award shall be made at the time of the Annual Convocation each year.

\* (Post-graduate student to be recommended for the award of the medal is meant a student who has passed the Master's degree examination in any Faculty in that particular year for which the medal is to be awarded or a student who has successfully completed at-least one year of the Master's degree course undertaken by him/her, and prosecuted studies further for the Master's degree examination).
