A) Qualification and Experience :

- (i) Good Academic record as defined by the concerned University with at least 55 % marks or equivalent grade in point scale wherever grading system is followed at the Masters Degree level in concerned / allied / relevant subject from an Indian University or an equivalent degree from an accredited foreign University.
