- 1. From the academic year 2016-17, it is decided to re-structure the B.Sc computer Science B.Sc Bio-Technology Programmes under the faculty of Science to make it more relevant to the core areas. Board of Studies for B.Sc Computer Science & B.Sc Bio-Technology will prepare the new re-structured syllabus with admission procedure, eligibility criteria and fee structure for the course.
- 2. To decided the Faculty for Courses which are common in two or more faculties for administrative convenience:
 - (a) Maths/ Stats/ Geography
- Science Faculty
- (b) Psychology / B.A.(Int. Design)
- Arts Faculty
- (c) Business Economics / Foundation Course Commerce Faculty
- 3. To follow the uniform 10 points Grading System with uniform Marketing Scheme for all Courses / all faculties, progressively from academic year 2016-17.
- 4. To scrap the internal evaluation of U.G Courses for Traditional Programs, progressively. The internal evaluation is to be continued as earlier for self Finance Courses. However, the scheme for allotment of marks in internal evaluation should be uniformed across all the faculties.
- 5. It is decided that, University shall send be Question Paper of F.Y. Examination in Arts, Commerce, Science, Law & Education Faculty for all courses in progressive manner from academic year 2016-17.
