**CIRCULAR:-**

The Principals of the affiliated colleges in Arts, Science & Commerce and the Heads of Recognized Institutions concerned are hereby informed that the approved by the Academic Council at its meeting held on 31<sup>st</sup> August, 2015 vide item No. 9.10 and subsequently approved by the Management Council at its meeting held on 16<sup>th</sup> January, 2016 vide item No.12. The ordinances 6302 & 6303 informed that the condition of Eligibility marks for admission to the courses under conventional faculties in now revoked. Therefore, from Academic Year 2016-17 onwards, the students with minimum passing marks in Lower Examination are now eligible to get admission to the Under Graduate & Post Graduate courses of conventional faculties read as under :-

“ज्या अभ्यासक्रमांच्या प्रवेशासाठी सेंट्रल काउंसिल किंवा शासनाचे किमान गुणांचे निकष असतील ते वगळता विद्यापीठाच्या इतर पदवी व पदव्युत्तर अभ्यासक्रमांच्या प्रवेशासाठी असलेली किमान गुणांची अट यापुढे काढून टाकण्यात यावी असे ठरले. त्यामुळे पदवी व पदव्युत्तर अभ्यासक्रमांच्या प्रवेशासाठी निकटतम कनिष्ठ परिक्षांमध्ये किमान गुण मिळवून उत्तीर्ण झालेले विद्यार्थी पदवी व पदव्युत्तर अभ्यासक्रमांना शैक्षणिक वर्ष २०१६-१७ पासून पुढे प्रवेश घेऊ शकतील”.

However, this concession will not be applicable to professional & such other courses wherever, the minimum eligibility marks criteria for admission is specified by their respective Central Councils/ Regulating Authorities, like UGC, COA, BCA, AICTE etc., which is available on the University's web site ([www.mu.ac.in](http://www.mu.ac.in)) and that the same has been brought into force with effect from the academic year 2016-17.


