The International Accounting Standards Committee (IASC) issuing International Accounting Standards went through some restructuring. It formed the International Accounting Standards Board (IASB) which issued International Financial Reporting Standards (IFRS). These standards have now become more or less Global Standards.

Ministry of Corporate Affairs decided that the Accounting Standards in India will converge towards IFRS, and with the help of ICAI, formulated new Standards based on IFRS called Ind AS.

The new Companies Act, 2013 was enacted and became applicable from 1st April 2014. On 16th February, 2015 under the new Companies Act, the Companies (Indian Accounting Standards) Rules, 2015 were notified. As per these rules Ind AS will be implemented in three phases, voluntarily from 1st April, 2015, mandatorily to some companies from 1st April 2016 and mandatorily for more companies from 1st April, 2017. Applicability depends on whether the company is listed or not, and on its Net Worth.

Ministry of Corporate Affairs has notified 39 Ind AS that will be applicable to companies as per the roadmap given in the Rules.

To enable you to gain a greater understanding of IFRS which is now applicable in India and facilitate development of finance professionals who are skilled in global standards, this workshop has been envisaged by the University of Mumbai, SIMSREE (Sydenham Institute of Management Studies, Research and Entrepreneurship Education) and ACCA (Association of Chartered Certified Accountants).
