2. Applications of only such officers/ candidates will be considered as are routed through proper channel and are accompanied by:-


- (i) Bio-data (in triplicate) as in the proforma at **Annexure -II**.



 - (a)(i) holding analogous posts on a regular basis in the parent cadre/ Department; or
 - (ii) with five years' service in the grade rendered after appointment thereto on a regular basis in the scale of pay Rs. 8,000 – 13,500 [revised to Rs. 15,600 – 39,100 + Grade Pay of Rs. 5,400/- (PB-3) as per 6th CPC] or equivalent in the parent cadre/ Department; and
 - (b) possessing the following educational qualifications and experience:-

Essential:-

- (i) Degree in Instrument Engineering/ Instrument Technology/ Electronic Engineering/ Electronic Engineering/ Electronics and Communication Engineering/ Electrical Engineering/ Mechanical Engineering of a recognized University/ Institute or equivalent;
- OR
- (ii) M.Sc. in Physics/ Applied Physics with Electronics as a special paper from a recognised University/ Institute or equivalent, and
 - (ii) five years experience of Teaching/ Research and/ or repair maintenance/ overhauling of various instruments used in Sugar Industry or Sugar Research Institute of repute.

NOTE:-

- (i) The Departmental Officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly deputationist shall not be eligible for consideration for appointment by promotion.
- (ii) Period of deputation (including short-term contract), including the period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization/ Department of the Central Government shall ordinarily not exceed four years. The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 56 years as on the closing date of the receipt of applications.
