The above post is open to all, however candidates from any category can apply for the post.

Reservation for women will be as per **University Circular No. BCC/16/74/1998 dated 10<sup>th</sup> March, 1998** & persons with disability will be as per **University Circular No. Special Cell/ICC/2017-18/05 Dated 13<sup>th</sup> June, 2017**.

Candidates having knowledge of Marathi will be preferred.

The pay-scale for the post of **Principal** is prescribed by the UGC, Govt. of Maharashtra & University of Mumbai from time to time.

The appointment for the post of Principal is a **tenure post of five years** or till the age of superannuation whichever is earlier.

The required minimum qualifications for the post of **Principal** are as follows:-

- I. A Master's Degree with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) by a recognized University.
- II. A Ph.D. Degree in concerned/allied/relevant discipline(s) in the institution concerned with evidence of published work and research guidance.
- III. Associate Professor/Professor with a total experience of fifteen years of teaching/research/administration in Universities, Colleges and other institution of higher education.
- IV. A minimum score of 400 as stipulated in the Academic Performance Indicator (API) based Performance Based Appraisal System (PBAS).

A relaxation of 5% may be provided at a graduate and master's level for the Scheduled Caste / Scheduled Tribe / Differently-abled (physically and visually differently-abled) categories for the purpose of eligibility and for assessing good academic record during direct recruitment to teaching positions. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and a relaxation of 5% to the categories
