Subsection 1.2:

- Sampling and techniques of data collection
- Issues of measurement in psychological research

Subsection 1.3:

- Probability and inference
- Correlation and regression
- Multivariate methods
- Factor analysis and SEM

Section II: Review paper (03 Credits)

Each research scholar is expected to engage himself or herself in in-depth review of relevant and recent literature in a broad area as decided upon mutually by the scholar and the research guide; and present a paper that highlights the possible lines of inquiry of his/her research focus with the existing literature and gaps to be filled in. The scholar, thus, is expected to critically review the literature in the identified or assigned area. At the end of the Semester, the scholar is required to submit both the hard copy and soft copy of such Review Paper accompanied with plagiarism report for evaluation.
