Dr. Dilip S. Patil, Professor & Director, DLLE and Chairperson of the meeting welcome the members and introduced them.

ITEM NO. 1

To Approve the syllabus of Extension Work & recommend to Academic Council, University of Mumbai.

Dr. Dilip S. Patil, Professor & Director, DLLE and Chairperson informed the members that the Department of Lifelong Learning & Extension has been entrusted the responsibility to start the subject of Extension Work in the colleges affiliated to University of Mumbai for the first year B.A., B.Com, & B.Sc. level. from the academic year 2016-17 as approved in the Academic Council.

The Director reported the Members that the Department conducted four meetings of UG and PG Senior Teachers conducting extension work activities at their colleges and also monitoring these activities on behalf of the Department in the capacity of Honorary Field Coordinator to discuss the contents of the syllabus to be framed by the Department for the subject of Extension Work. On the suggestions of various Experts, the contents are designed by the Board of Studies Members considering the various aspects and need of the society. The members appreciated the contents of the syllabus and it was resolved as under:

“Resolved that the syllabus of Extension Work be approved & recommended to Academic Council, University of Mumbai for further action.”

ITEM NO. 2

To organize Orientation Workshop for Extension Work Teachers and Principals of the affiliated colleges.

Dr. Dilip S. Patil, briefed the members about the need of such Orientation Workshop for Extension Work Teachers and Principals of the affiliated colleges. The discussion was held among the members and their suggestions are noted as given below:

- It was suggested to conduct the meeting in the colleges where the board members are teaching so that the board member can take the responsibility of smooth conduct of Orientation Workshop in a first phase.
- It was also suggested that these meetings may be conducted in adjoining to Second Term Training Programs of the Department district-wise.

Further, Dr. Dilip S. Patil, Chairperson, informed the members that Dr. Bharmal, Principal, S.P.K. College, Sawantwadi, Dist: Sindhudurg has agreed to conduct such kind of meeting in his college for the colleges located in Sindhudurg district.

Finally, it was resolved as under:

“Resolved that the Organization of Orientation Workshop for Extension Work Teachers and Principals of the affiliated colleges and Students Training be conducted separately and district-wise be accepted and approved”
