I am to invited your attention to Ordinances, Regulations and Syllabi relating to the Master of Science (M.Sc.) (Home Science) degree program Vide this office Circular No. UG/ICC/2015-16/127, dated 5<sup>th</sup> December, 2015 and to inform you that the recommendation made by the Ad-hoc Board of Studies in Home Science at its meeting held on 6<sup>th</sup> May, 2019 have been accepted by the Academic Council at its meeting held on 10<sup>th</sup> May, 2019 (Vide item No. 4.25) and subsequently approved by the Management Council at its meeting held on 1<sup>st</sup> June, 2019 (Vide item No. 13) and that in accordance therewith, in exercise of the powers conferred upon the Management Council under Section 74 (4) of the Maharashtra Public Universities Act, 2016 (Mah. Act No. VI of 2017) and the amendment of Ordinance 3545 relating to the Eligibility criteria for admission of P.G. Diploma in Dietetics & Applied Nutrition, has been brought into force with effect from the academic year 2019-20 accordingly.
