

5. Diploma in Translation.

It was **resolved** that it be recommended to the **Academic Council** that the duration & intake Capacity of **Diploma in Translation** be amended to read as under and that same be brought into force with effect from 2019-20:-

Existing:-

R 8519 Duration:-

The duration of part time Course Diploma in Translation (French) shall be of one academic year, i.e. two academic terms.

4 hours per week + 2 hours tutorials.

R 8520 Intake capacity minimum 10 students.

Amended:-

R 8519 Duration: 1 academic year; Weekly hours: 4 hours; total max. 120 hours

R 8520 Intake capacity : 35 students

Minimum number of students required: 06
