Subsequently the plaintiff claimed damages due to loss of their property owing to the negligence of the hotel staff

- (b) The defendant offered to sell his farm to the plaintiff for 50,000/- Rs. The plaintiff replied that he would pay Rs. 45,000/- which was refused by the defendant. Plaintiff then agreed to pay Rs. 50,000/- Defendant, however, now refused to adhere to his original offer
- (i) What does plaintiff's reply to pay Rs. 45,000/- known as?
