- 3. Those professors who are likely to be appointed as paper setters, moderators and examiners for the University Examinations their names should not be recommended & keep them free for the purpose of assessment.
- 4. The professors recommended should be physically fit to perform the Vigilance Squad duties.
- 5. The professors once appointed for the examinations of First Half of the 2020 will also be continued to work on Vigilance Squad for the examination of Second Half of 2020.
- 6. The Heads of University Departments shall send the names of their professors for the said purpose.
- 7. The Colleges Department/Institutions fails to furnish the names of the professors of their colleges, the examination section will appoint the professors on the Squad from their Department/Institutions.
- 8. As per the Maharashtra Public University Act 2016 48(5) it shall be obligatory on every professor of the University, affiliated, conducted or autonomous college or recognized institutions to render necessary assistance and service in respect of examinations of the University.
