CIRCULAR

The Principals of Law colleges, Directors Thane Sub Campus and Director, University Of Mumbai - Law Academy (UMLA) are hereby informed that the pattern for LLB 3years and 5years examinations (First half of 2022) is as follows -

The instructions given in circular of No DBoEE/ ICC/2021-22/23 dated 23rd February, 2022 will apply.

The following are the supplementary instructions -

- 1. All examinations of semesters of LL B 3 years and 5 years(Semesters 1 to 10) will be held offline. Detailed timetable will be issued shortly.
- 2. Question papers for these examinations shall be delivered by the University as before. The colleges will bear the responsibility of assessment and results of LL B 5 years semesters 1 to 8 and LL B 3 years semesters 1 to 4.
- 3. All law colleges will be centres (self centres) for their respective students for the LL B programmes. University will deliver stationery for semesters 5,6 of 3 years LL B and 9,10 of 5 years LL B.
- 4. Paper pattern of all the examinations except semesters I of 3 years and 5 years LL B regular will be same as earlier exams immediately preceding this examination ie 20 MCQ for 30 marks and 10 Descriptive for 30 marks). Semesters I will have the regular conventional question paper as applicable before corona.
- 5. Students shall answer the MCQs part by writing the question number and the correct option against the question number.
 - Eg 1 b
 - 1 a
 - 2 d
- 6. MCQ Question paper should be collected after first half hour. Students will continue to answer the descriptive questions in the same answer book. Question papers shall be printed to enable such collection of MCQs part after first half hour.
- 7. Students will get 1 hour and 53 minutes (including 15 minutes per hour extra time)
- 8. After each exam the answer books of all students will be collected by University for OSM. Every college shall mandatorily contribute to the assessment by OSM. Every college shall complete the quota of 1.5 times the number of papers of its students.

- 9. LL B 5 years semesters 7, 8, 9,10 Question paper pattern will be same as that of semesters 1 to 6. The marks obtained out of 60 shall be extrapolated to a score out of 100 marks.
- 10. Students in 60: 40 pattern of semester 6 of 3 years LL B even if they have backlog only in Practical training III of Semester 5, they shall fill in semester 5 exam form of University. In a like manner if the student has only internal examinations to appear semester 5 exam forms have to be filled in and fees have to be paid accordingly. Practical Training shall be counted as 1 paper and accordingly fees shall be paid. Colleges shall inward such forms of their students.
- 11. Post Graduate diploma courses exams shall be offline. The paper pattern will be same as what was before Corona- the conventional one. Law Dept and Colleges that offer those programmes shall conduct and send results to the University Examination House.
